**Memorandum of Understanding

University of Macerata

Shanghai University of Political Science and Law  
of  
Cooperation on Exchange Programs**

University of Macerata, Department of Law and Shanghai University of Political Science and Law agree to cooperate in regard to international programs based on the principle of reciprocity. This Agreement permits the exchange of scholars, students, academic information and materials between the signatory institutions.

1. The universities agree to promote the following exchange activities based on their respective academic and educational needs.
  - a. Exchange faculty between universities.
  - b. Exchange students between universities in short or long term and degree or non-degree programs, and credit transfer between the parties.
  - c. Joint research in fields of mutual academic interests.
  - d. Joint hosting of academic conferences and seminars/workshops.
  - e. Exchange of teaching materials and curricula.
2. Collaborative programs will include faculties, undergraduate and graduate levels.
3. This Agreement will be in force for five years and is subject to revision or renewal by mutual agreement.

This MoU is made in English and Chinese for both universities. This MoU is effective when the representatives of both universities have affixed their signatures to the MoU.

## 上海政法学院与意大利马切拉塔大学

### 合作交流谅解备忘录


